1. Apologies:

Apologies were received from County Councillor David Barnard and Parish Councillor Colin Everett

2. Minutes:

The minutes of the previous meeting which have been circulated to all the Parish Councillors were agreed to be a true record and were duly signed by Ms Hart.

3. Matters to report:

3.1 Police Report-There was no Police present and no report received. Mr Kelly reported that there had been some individuals riding motorcycles without helmets through the village and roads. The Police are aware of this and will be monitored.

3.2 County and District Councillors Report:

Mr David Barnard sent an e-mail to inform the Parish council that he was pursuing the 20 mph through the villages of Pirton and Holwell.

Sam North reported that he had been contacted by a Parishioner regarding the sewage problems in Holwell and his concerns that with further housing developments proposed in the village this problem would be further exasperated. Recently three Anglia Water vehicles were called out late at night to deal with this problem. The PC confirmed that this was an ongoing problem dating back many years. The sewage system was out dated and needed extensive work to be carried out. Mr North agreed to look into this matter and contact the water company for their comments. Mr North also advised the PC to write to Anglia Water.

Cala Homes – The reinstatement of the lay-by on Holwell Road. Ms Hart has written to Highways and has not received a reply. Cala Homes reported that they were waiting for Highways to deal

with this. Mr North agreed to raise this matter with Highways. The lay bye is also being used for general parking and fly tipping/fowling since the monitoring officers have been removed.

3.3 Recreation Ground Issues:

Pavilion: The clerk reported that she had contacted a number of builders for quotes for the proposed new Pavilion. These will be sent to Claire Morgan at North Hertfordshire District Council to support the application for a grant towards the new build. An application for a grant from Settle Housing has also been applied for.

Children's Play area: The play area has been registered for the annual inspection through NHDC and this will be carried out in November. The play area is now open to the public. The clerk was instructed to contact CPM Playgrounds Limited to arrange repairs to the safety surface around the climbing frame.

Trees in Children's Play area: Parishioners complaint re trees – The trees have now been cut back and debris removed and the Horse Chestnut suckers have been removed from this area.

Trees over hanging/broken on the recreation ground from The Rectory - These need cutting back as our Tree Specialist has advised as they could cause a hazard/danger to walkers using the footpath in the far corner of the recreation ground. It is suggested that the PC write to Mr Lyons regarding this.

Rights of Way update: access to play area from Holwell Road (definitive map) -pending due to appeal.
